# ROYAL SUTTON COLDFIELD CHAMBER OF COMMERCE NOMINATIONS FOR THE ELECTION OF CHAMBER OFFICERS AT THE ANNUAL GENERAL MEETING ON Monday 7<sup>th</sup> July 2025

### 1. President

Under the Chamber's Constitution, Naeem Arif will have served his 2-year term as President of the Royal Sutton Coldfield Chamber of Commerce and therefore will retire this year. This creates one vacancy for this role.

Under the Chamber's Constitution, Gary Phelps will be nominated as new President of Sutton Coldfield Chamber for new two-year term.

### 2. Vice Presidents

Under the Chamber's Constitution, the two-year term of Kate Curry has end, creating one Vice-President vacancy. With Gary Phelps' nomination for Presidency, there will be a further Vice-President role available. - Will Crawford will continue another year co-opted onto the Executive Committee in his capacity as Future Faces Ambassador.
